**REACH Conference 2017** is organized for the tenth time combining lecturers and participants from different sectors of industry, authorities, academia and other stakeholders. Now we are in the full speed of REACH legislation (10 years on) requiring attention of many companies including SMEs which will need to allocate expertise and time = investment for compliance.

**REACH registration 2018 deadline** will be a challenge especially for SMEs. Subsequent duties for downstream users in the supply chain are under implementation. Exposure scenarios and e-SDSs are more and more frequent and creating new tasks for all of involved. Also authorisation process is on the place—the Candidate list now containing a total of 173 entries and the Authorisation list contains 31 unique substances/entries. Further restrictions are applied by revision of Annex XVII. Overlaps with other legislative sectors is under evaluation, but very important is the REACH REFIT evaluation (REACH Review 2017).

Experiences, difficulties, learning lessons as well as good practices will be discussed during the REACH Conference 2018...

## RMO(A) TRAINING WEDNESDAY MAY 24, 2017

**Risk Management Option analysis (RMOa)** is a tool that got last year's increasing attention from regulators as well as industry. The tool is used when any of the REACH processes (Classification and Labeling, Dossier or Substance Evaluation) or a Member State identifies a "concern" to check what could be the most relevant risk management tool to handle the outstanding risk or concern.

While originally focused on SVHC substances (see EU SVC Road Map) the RMOa assessment is presently used to assess the consequences of any concern that would warrant further risk management.

Member states use the RMOa tool to assess if the concern:

- Does not need any further handling
- Requires a handling beyond REACH (e.g. OSH legislation, EQS legislation, ...  
Should best be handled under REACH (CI&L, authorization restriction, ...)

The latter would then trigger an Annex XIV launching this REACH-RMM route.

Planned RMOas are announced on PACT being sometimes at short notice allowing stakeholders to provide input. The latter is quite relevant given RMOa relevant information is not always part of the registration requirements.

The drafting of an RMOa therefore includes many challenges both for member states (MSs), industry as well as for ECHA and the Commission:

- The availability of information not part of the registration requirement;
- How much does the risk/exposure under consideration contribute to the overall risk, exposure;
- Relevancy and efficiency of existing risk management measures (RMMs);
- Potential for substitution, reduction of emissions or other exposure based RMMs;
- How to promote that different RMOas guarantee a minimal quality/relevancy level.

### **The responsibility of industry under REACH is mainly related to the registration file.**

The challenges above as well as to increase the attention and focus of industry to develop RMOa relevant information in advance of a regulatory initiative, or even better to check the relevance and anticipate the need for RMM for any concern, were clear motivators for industry to develop an RMO methodology, guidance and pilot cases aiming for anticipation, preparation and early identification of relevant information to clarify or clear an RMM concern.

### **RMOa Training will provide you with an opportunity to:**

- Learn about how RMOa can help industry to apply a critical review of its processes and substances to check for the need for risk management measures (RMM) for outstanding concerns (sensu largo);
- What approaches can be used and what steps may help you to conduct such an evaluation;
- How industry—RMOas can help defining / anticipation the most relevant lacking information packages from the registration file;
- What data could help regulators to better assess the most relevant RMM;
- To identify the relevancy or a use or an exposure in the overall exposure to define the most relevant sources to be tackled;
- Learn from pilot cases that applied the method to help industry or regulators to define the relevancy and need for RMM.

### Praktický seminář REACH REGISTRACE

#### Registrovat chemické látky musí podle nařízení REACH:

- výrobce nebo dovozce (EU) látek jako takových nebo ve směsi,
- výrobce nebo dovozce (EU) předmětů splňujících kritéria vysvětlené v Pokynech ohledně požadavků na látky v předmětech,
- „výhradní zástupce“ se sídlem v EU a jmenovaným výrobcem, formulátorem nebo výrobcem předmětu se sídlem mimo EU za účelem plnění registračních povinností dovozce.

Registrace se týká látek jako takových, látek ve směsích a v určitých případech také látek v předmětech. Chemické látky, které už podléhají jiným právním předpisům, jako jsou léčiva nebo radioaktivní látky, jsou z požadavků nařízení REACH částečně či zcela vyňaty.

**Nařízení REACH** je založeno na tom, že průmysl by měl vyrábět, dovážet, používat a uvádět na trh látky takovým způsobem, který na základě rozumných předvídatelných podmínek zabezpečí, že tyto látky nemají nepříznivý dopad na lidské zdraví a životní prostředí. Aby bylo možné toto zabezpečit, musí výrobci a dovozci vytvořit souhrn údajů o látkách a posoudit, jak je možné regulovat rizika jejich dopadu na lidské zdraví a životní prostředí aplikováním vhodných opatření řízení rizik.

Aby bylo možné doložit splnění těchto povinností, požaduje nařízení REACH i z důvodů transparentnosti od výrobců a dovozců, aby při registraci předložili Evropské agentuře pro chemické látky (ECHA) následující materiály:

1. technické materiály, včetně údajů o látce;
  2. v případě látek s množstvím větším než 10 tun za rok na jednoho registrujícího i zprávu o chemické bezpečnosti, která hodnotí, jak je možné regulovat rizika dopadu na lidské zdraví a životní prostředí;
- Registrace je založena na principu „jedna látka, jedna registrace“. To znamená, že výrobci a dovozci téže látky musí předložit svou registraci společně. Poskytnuté analytické a spektrální informace by měly být konzistentní a dostačující k potvrzení identity látky.

Za registraci látky je obvykle účtován poplatek.

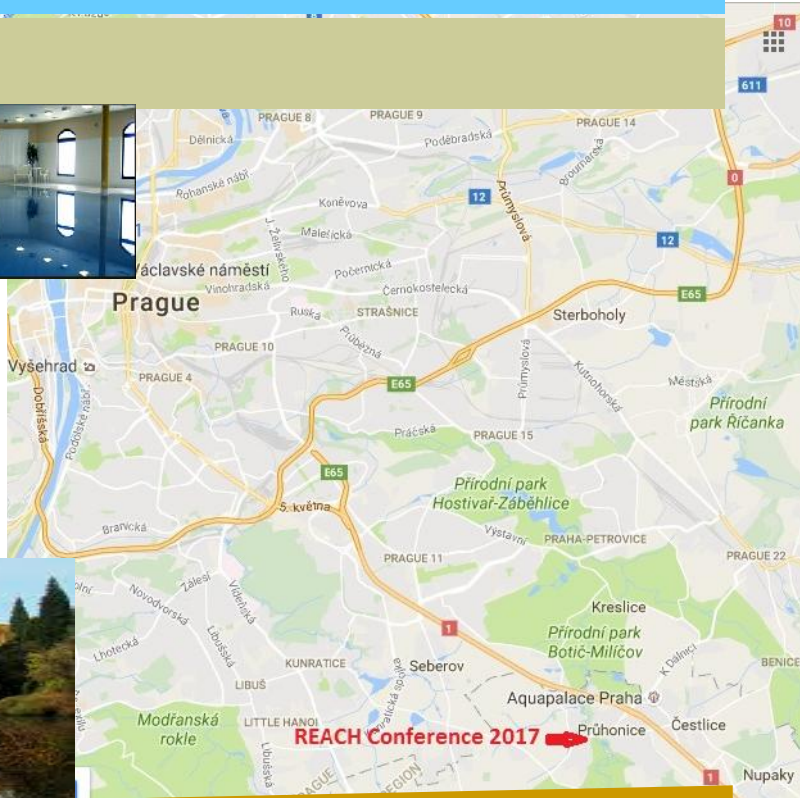

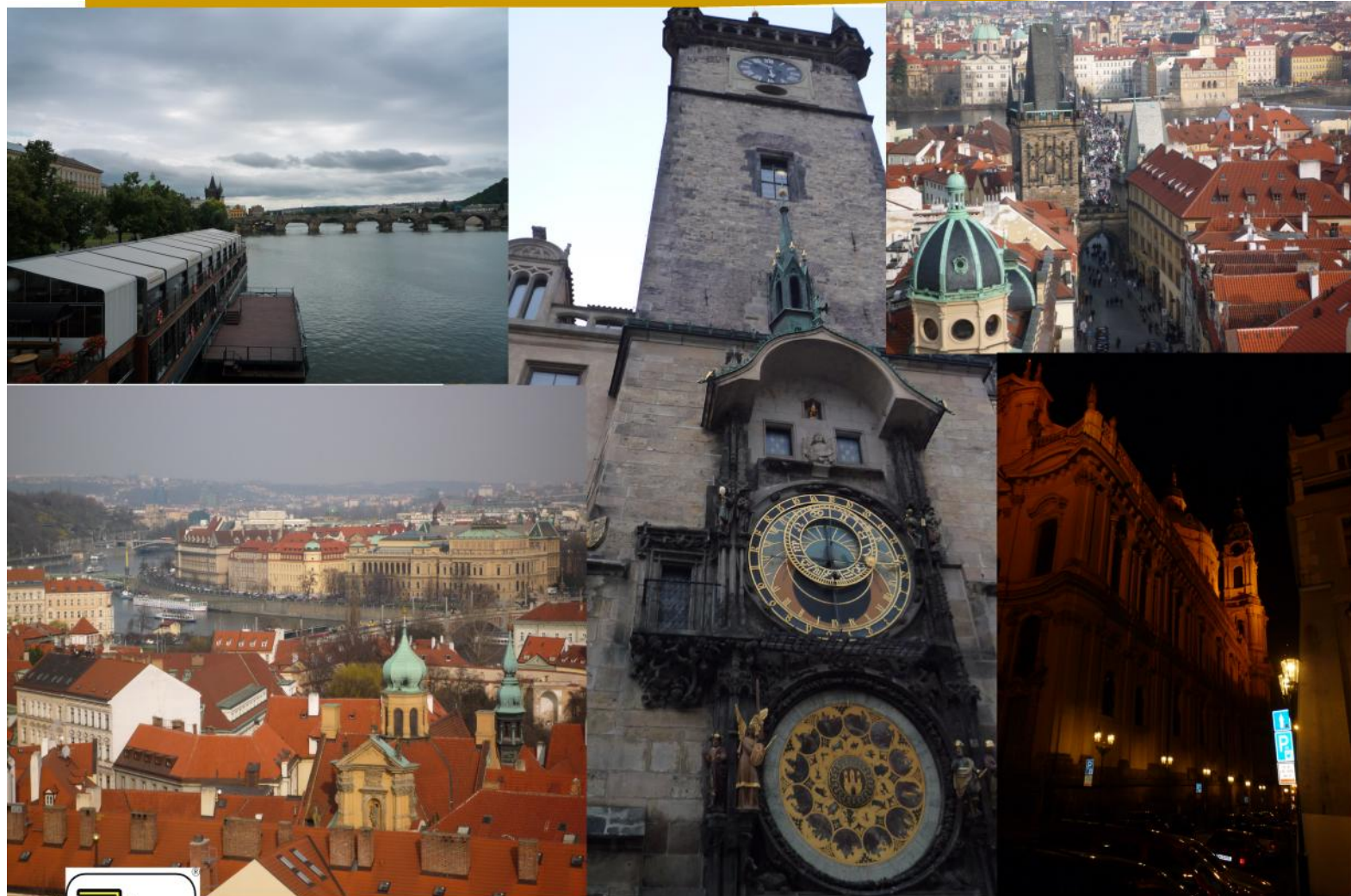

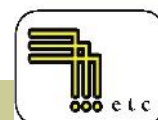
